IN 2016 SAHA HOSTED 100 FIELD REPS IN GHANA. ALL OF THE FIELD REPS WERE HOSTED IN TAMALE. 42 OF THESE FIELD REPS PARTICIPATED IN OUR SOLAR PROGRAM AND 58 PARTICIPATED IN OUR WATER PROGRAM. THESE FIELD REPS HELPED SAHA TO LAUNCH 11 NEW SOLAR ELECTRICITY BUSINESSES AND 15 NEW WATER BUSINESSES. THESE 15 WATER BUSINESSES PROVIDE PERMANENT ACCESS TO CLEAN WATER TO APPROXIMATELY 5,618 PEOPLE AND THE SOLAR BUSINESSES PROVIDE PERMANENT ACCESS TO ELECTRICITY TO APPROXIMATELY 3,960 PEOPLE. COMBINED, THESE BUSINESSES ALSO PROVIDE JOB OPPORTUNITIES TO 73 GHANAIAI WOMEN ENTREPRENEURS.

WHEN SAHA IS NOT HOSTING FIELD REPS IN GHANA, OUR GHANA STAFF IS IN CHARGE OF MONITORING THE SAHA WATER AND SOLAR BUSINESSES. EACH STAFF MEMBER (THERE ARE 5 FULL-TIME) IS IN CHARGE ABOUT 12-18 VILLAGES EACH. THEY VISIT BETWEEN 2-4 VILLAGES EACH DAY. WHEN IN THE VILLAGE, STAFF MEMBERS SPEAK WITH THE WOMEN ENTREPRENEURS WHO RUN THE WATER OR SOLAR BUSINESSES AND INTERVIEW THEM ABOUT SALES. GEOGRAPHIC EXPANSION - IN 2015, SAHA DECIDED TO EXPLORE THE OPTION OF EXPANDING OUR WORK TO A NEW COUNTRY. THE EXPANSION-RESEARCH EFFORTS WERE LEAD BY SAM REILLEY AND WE DECIDED TO EXPAND OUR WORK TO NICARAGUA. IN 2016, DUE TO THE OUTBREAK OF THE ZIKA VIRUS AND THE REALIZATION THAT THERE WAS STILL SIGNIFICANT WORK TO BE DONE IN NORTHERN GHANA, WHERE 800,000 PEOPLE STILL LACK ACCESS TO CLEAN WATER, WE DECIDED TO ABANDON THIS INTERNATIONAL EXPANSION AND FOCUS ON GROWING IN GHANA.
