DUE TO THE COVID 19 PANDEMIC RESTRICTIONS, IMPLEMENTATION OF NEW WATER BUSINESSES WERE PAUSED AT THE END OF MARCH 2020. RESOURCES FROM THE IMPLEMENTATION TEAM WERE UTILIZED TO SUPPORT EXISTING WATER BUSINESSES AND TO AID IN INSURING THAT THESE BUSINESSES AND SURROUNDING COMMUNITIES WERE INFORMED AND ADHERING TO COVID 19 SAFETY PROTOCOLS.
